

# PIMCO TRENDS Managed Futures Strategy Fund

## PERFORMANCE SUMMARY

The PIMCO TRENDS Managed Futures Strategy Fund returned -2.73% (Institutional, Accumulation shares net of fees) in May. Year-to-date the Fund has returned 0.97% (Institutional, Accumulation shares net of fees).

The portfolio declined overall in May as losses in currencies, interest rates, and commodities outweighed gains from equities.

Global equities rose on strong earnings while yields ended lower as investors continued to assess the path of monetary policy. Commodities rose overall driven by gains across most subsectors despite losses in oil prices. Meanwhile, the Dollar weakened due to weaker-than-expected U.S. economic data. The MSCI World Equity index returned 4.5%, the Bloomberg Global Aggregate Index rose 1.3%, the Bloomberg Commodity Index was up 1.3%, and the Bloomberg Dollar Spot Index declined -1.1%.

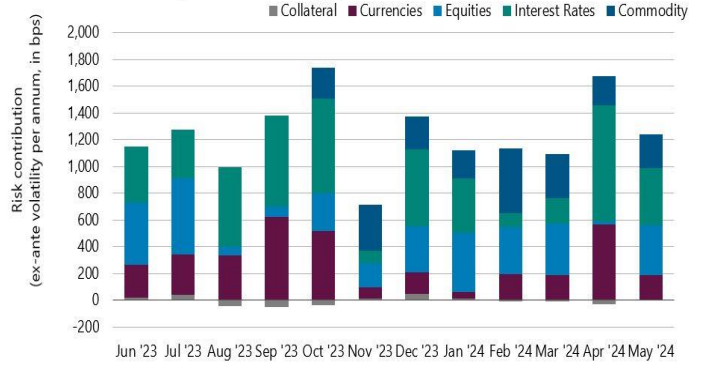

### MONTH IN REVIEW

Overall global sovereign yields declined while equities rose, and the U.S. Dollar ended weaker over the month. Meanwhile, commodity prices ended higher as most subsectors rose except for energy. The portfolio incurred overall losses over the month, driven by declining global rates and weakening USD through short positions across global interest rates and FX vs. the Dollar. The portfolio's short positions in agricultural commodities also detracted as prices rose within the subsector. Meanwhile, the portfolio's long positions in precious metals, DM European equity indices, and short positions in U.S. volatility index contributed.

### PORTFOLIO POSITIONING

The overall volatility decreased in May as the portfolio decreased its short duration and long USD exposure over the month following reversals. Meanwhile, the Fund maintained its overall long equity and commodity exposures.

Over the long run, the portfolio continues to deliver low correlations to underlying asset classes. Since inception (June 30, 2015) correlations:

- MSCI World Equity Index: -0.25,
- Bloomberg Global Aggregate Index -0.14,
- Bloomberg Commodity Index -0.15,
- Bloomberg Dollar Spot Index 0.19.

## OUTLOOK AND STRATEGY

The fund pursues a disciplined approach to trend following, providing exposure to global markets including currencies, equities, interest rates and commodities\*. The fund uses proprietary quantitative models that are designed to identify price trends through both long positions that seek to benefit from rising prices and short positions that seek to benefit from falling prices. The fund is exposed to a wide range of global markets across asset classes, but seeks low long-term correlations to any particular asset class through its ability to dynamically take both long and short positions. Accordingly, market environments with persistently high volatility and persistent trends may be more favorable for the fund than market environments characterized by sharp trend reversals or persistently low market volatility without persistent trends.

Importantly, the dynamic nature of the strategy allows the portfolio to adapt quickly to changing market conditions.

\*Starting in October 2023, the GIS TRENDS portfolio expanded its investment universe to include commodities consistent with its investment policy.
